BBEDC Seafood Industry Investment Officer Paul Peyton and corporate legal counsel Jim Barnett have both retired from their positions. Bycatch and interception of salmon stocks has been an area of concern for BBEDC since our beginning. Outreach Community Liaison Program

Through the BBEDC Community Liaison Program grants are made available to each CDQ community (city or tribal organization) to fund a position that serves as a Liaison in their community. The position is critical for assuring that residents are provided with current information and easy access to BBEDC program information. The individual is an employee of the grant recipient and in most cases provides additional support to the organization with other administrative tasks. In 2021, BBEDC Community Liaisons reported almost 1,000 individual contacts with residents to provide information and assistance. Grants of \$54,200 were available to each of the 16 community applicants, for a total investment of \$826,550. The current BBEDC Community Liaisons are:

Community Liaison Program

Providing information to our community governing organizations and residents through our Liaisons is a hallmark of the BBEDC Community Liaison Program. Liaisons devote significant time to maintaining their knowledge of programs by participating in monthly teleconferences and annually attending a training event provided by BBEDC. The continuing COVID pandemic was the incentive to avoid gathering in-person, so the annual Community Liaison Training was hosted as a virtual event. Many attended through videoconference and others through teleconference. Material was provided to each Liaison in advance through email, fax, and USPS. The response from participants was very positive with 22 participants that included Community Liaisons, their supervisors, and guests from other community governing organizations. The cost of the training was significantly reduced from prior years with a total of \$711 for 2021.

Economic Development Community Block Grant Program

BBEDC has invested over \$100,000,000 in community grants since 2002. Community grants, such as the Community Block Grant Program, provide BBEDC communities with the opportunity to fund projects that promote sustainable community and regional economic development. In addition, communities may choose to use Community Block Grant funds to assist eligible resident households in the respective BBEDC communities to purchase home heating fuel and/or electricity or to fund operations and maintenance (O&M) of buildings and ice machines to which the community owns title.

Permit Services and Assistance Emergency Transfer Grant Program

Access to a limited entry permit and experience is a critical step toward permit ownership and ultimately entry into the Bristol Bay fishery by residents. The Emergency Transfer Grant Program helps residents obtain a temporary permit under a CFEC approved Emergency Transfer. A temporary permit transfer provides an opportunity to explore commercial fishing as a feasible income generating activity, earn funds for the down payment necessary to purchase a permit, and enhance a person's knowledge of the fishing industry. In 2021, BBEDC invested \$168,900 and provided an opportunity for 21 resident fishers to acquire a permit under an emergency transfer. All recipients must develop an Individual Development Plan (IDP) that outlines personal objectives toward ownership of a permit in the foreseeable future.

Maason is very familiar with commercial fishing and working as a crew member has been his primary source of income in recent years. Maason intends to become a permit holder and establish his own commercial fishing operation. The Emergency Transfer Grant helped him save a considerable amount on his lease payment and allowed him to apply those savings towards setting himself on the path to purchase his own Bristol Bay set net permit and continue fishing in Bristol Bay.

Business of Fish

BBEDC encourages program participants to stay abreast of new techniques, equipment, trends, and changes in the industry. The Business of Fish is an annual workshop coordinated by BBEDC to provide a forum for program participants. BBEDC invested a total of \$5,005 and partnered with the Alaska Marine Safety Education Association (AMSEA), the Sea Grant Marine Advisory Program (MAP), and Information Insights, Inc. to provide multi-day virtual workshops in 2021.



Permit Loan and Vessel Acquisition Program participants that attended the virtual workshops were able to apply the accumulated hours toward program annual eligibility requirements.

Permit Services and Assistance Interest Rate Assistance Program

The Interest Rate Assistance (IRA) Program assists resident fishers with a portion of the interest on loans specifically for the purchase of a limited entry permit, a commercial fishing boat, or commercial fishing gear. As interest rates begin to increase, the assistance provided through the BBEDC IRA is valuable to residents that seek to obtain a loan for fishing related purposes. The majority of participants reported that the loan and savings gained from the IRA were invested in improvements to their vessels and added gear; all of which makes the resident's operation more profitable and competitive. BBEDC assisted 11 resident fishers by paying \$29,217 in interest assistance in 2021.

Shore Fish Lease Grant Program

A shore fishery lease issued by the Alaska Department of Natural Resources (DNR) can enhance the income potential and allow for some certainty of access to a site for eligible set net fishing residents. A shore fishery lease is not required for set net fishing; however, it can provide certainty that the individual will be able to fish a location. The Shore Fish Lease Grant Program provides financial assistance and incentive in the form of a grant of up to \$800 for resident set net permit holders to navigate the complex and cost prohibitive process of gaining a shore fishery lease. No grants were issued in 2021 but one grant recipient was allowed to carry a portion of a grant over from the preceding fiscal year.

Bristol Bay Permit Brokerage

Permit Brokerage services are provided to support resident ownership of permits through technical assistance and services designed to enhance resident success and inhibit or reverse the migration of limited entry salmon permits out of the Bristol Bay region. In 2021, over 127 individuals were assisted with fishing related transactions outside of other BBEDC programs. Brokerage staff provide technical assistance with completing loan applications for purchasing or upgrading fishing operations, crew contracts, emergency transfers, permanent transfers, regulatory requirements relative to permit and vessel ownership and reporting requirements associated with the Alaska Commercial Fisheries Entry Commission and the U.S. Coast Guard. BBEDC collected and paid over \$24,000 in fees to agencies in the process of providing technical assistance to brokerage clients.

Permit Loan Program

Limited Entry salmon permits held by Bristol Bay watershed residents have declined since the original inception in 1975; from 1,270 to 669 (CFEC Permit Database 1/21). The declining number of permits has severely diminished the overall commercial salmon fishing income generated by residents making out-migration of permits one of the most detrimental economic events in the Bristol Bay region. Retaining and returning limited entry permits to the region continues to be a BBEDC priority. The Permit Loan Program enhances residents' ability to purchase and successfully operate a limited entry salmon permit through a menu of financial and technical services including loan guarantee, down payment grant, interest assistance, principal reduction assistance, technical assistance and/or training to successful applicants. Participants are selected through an evaluative process and the program is unique in that it is available to residents of all the 25 Bristol Bay watershed communities.

Permit Services and Assistance Permit Loan Program (continued)

Four participants were added in 2021 which brought the total to 60 continuing participants. BBEDC invested a total of \$340,455 for new entries, committed equity assistance (sweat equity) and interest subsidy.

Jesse has lived most of his life in Dillingham and feels that he was born to be a commercial fisherman. When asked what his goal was for his fishing future, he shared the following, *"Since 2015 I dreamed about the day of becoming a permit holder. That would be the goal, to be a skipper, can't be a follower and deckhand my whole life."* Jesse's goal became a reality in 2021 when he purchased a drift permit through the BBEDC Permit Loan Program.

Vessel Acquisition Program

Success in the Bristol Bay fishery for most permit holders is heavily dependent upon access to the necessary equipment, which includes a vessel. Enhancing the ability of residents to obtain a competitive and efficient vessel is the focus of the Vessel Acquisition Program. Vessel may also mean a licensable truck provided that the applicant can demonstrate that a vehicle is the primary vessel for their individual fishing operation at the point of harvest and delivery. The program can provide a down payment grant, interest subsidy, equity assistance, RSW Incentive, training, and technical business counseling. Applicants must be able to obtain a loan through one of BBEDC's partner lenders (CFAB or DED) or any established lending institute that can be considered under this program. In 2021, five resident drift fishers entered the program, bringing the total participants to twenty-nine. Four of the five applicants were influenced to seek vessels with RSW systems because of the incentive provided under the Vessel Acquisition Program. The cumulative investment by BBEDC in 2021 was \$329,347 for down payment grants, RSW incentive and committed annual "sweat" equity, and interest subsidies.

Economic Development Program Services Technical Assistance Program

Our region's entrepreneurs, including commercial fishers, are an asset to be cultivated, motivated, and rewarded. Healthy and thriving businesses generate resident jobs and economic activity that is beneficial to the region. BBEDC's Technical Assistance Program promotes business planning and development whether it is a commercial fishing operation or other small business. Through partnerships with the Alaska Business Development Center (ABDC) and Agnew::Beck Consulting, resident entrepreneurs,

community organizations, nonprofits, and private citizens are provided with professional business consultation. There also continued to be a need to assist individual residents and fishers as well as some organizations to take advantages of opportunities for COVID related funding. In 2021, \$33,517 of consulting time was invested in resident technical assistance. An additional \$36,442 was invested in the provision of assistance specifically for applicants and participants in the Emergency Transfer Grant Program, Permit Loan Program and Vessel Acquisition Program.

Grant Writing Assistance

Bristol Bay communities rely on federal, state and private granting sources for the development and replacement of critical community infrastructure as well as for development that results in income generating opportunities for residents. BBEDC's Grant Writing Assistance Program provides the services of selected grant-



writing consultants for funding searches, proposal pre-development, pre-applications, proposal development, proposal follow-up and proposal review. In 2021, \$37,880 was invested in professional consulting assistance for preparation of proposals submitted by BBEDC communities to granting agencies. Individual grant proposals required up to 100 hours of consultant time in some cases due to the complexity.

Grant E-Newsletter

BBEDC provided for the publication of a quarterly Funding Opportunities E-Newsletter in 2021. The e-newsletter is produced by Agnew::Beck Consulting as a part of the contract with BBEDC for grant writing assistance. The newsletter provides information about current government and private grants with an emphasis on resources of interest to BBEDC communities. The E-newsletter is distributed to all BBEDC communities through direct email and posted on the BBEDC website www.bbedc.com.

Economic Development Program Services Personal Finance/Education Program

Establishing and maintaining positive personal credit continues to be the greatest challenge for residents that want to obtain a limited entry permit or fishing vessel. It can also be a roadblock for home ownership and other important purchases. BBEDC partners with the non-profit firm, Money Management International (MMI), to act as a resource to residents. The staff of MMI counsels residents on a one-on-one basis, leads workshops that provide financial education to groups of residents and registers individual clients for debt repayment plans. In 2021, travel restrictions prevented in-region workshops but work with clients continued by videoconference, email, telephone, and US Mail. BBEDC invested \$12,018 in this program in 2021 with fifty residents receiving individual attention. MMI serves an important role in the personal financial counseling for Emergency Transfer Grant recipients and for credit review/counseling for potential Permit Loan Program and Vessel Acquisition Program candidates.

Tax Preparation Program

BBEDC's Tax Preparation Program awards eligible residents up to \$150 toward the preparation of individual tax returns. The program seeks to reduce the number of residents filing late and/or inaccurate returns or not filing returns. It also assures that revenue is returned to the region in the form of tax refunds. The program also seeks to support tax preparation businesses that are located within the region. Among other criteria, the Tax Preparers must be IRS certified and maintain current training. In 2021, participating IRS certified tax preparers, William Scheid and Jerry Liboff produced 922 tax returns for a total expenditure of \$138,419 and a projected net return to the region of \$1,030,135 in IRS tax refunds.

Youth Employment and Education Arctic Tern Grant Program

The Arctic Tern Program provides an opportunity for BBEDC communities to address the challenge of limited opportunities for employment and educational activities for youth under the age of 17. Grants of up to \$6,000 were made available to each BBEDC community in 2021. Communities continued to overcome challenges created by the COVID pandemic by developing creative programs that could be conducted in a safe environment. A cumulative total of \$27,000 was awarded to five communities and a total 42 youth were employed. Over 450 residents were served through the youth positions supported. Projects included a community-wide cleanup event, packing/ loading recycled material to be back-hauled out of the community, a community-wide outdoor Halloween event called the "Pumpkin Patch" that included distribution of pumpkins, carving kits and health/safety material, and a Community Helpers Program that employed young people to provide home services for residents in need.

Employment Seasonal Employment Opportunities Program

The Seasonal Employment Opportunities Program provides short-term employment opportunities anywhere from 4-16 weeks for the region's residents. This gives residents experience in jobs that will boost their resumes for future employment while also giving employers the opportunity to train someone that they could someday hire on full time. These entry level positions are vital to some of the businesses in the CDQ communities during their busiest months of the year. BBEDC worked with local businesses and was able to support employment positions including an Office Assistant, Land Use Agent, Building and Grounds Laborer, Radio Announcer, Nurse, and more. Over the course of 2021 seasonal employment employed 23 residents with a total cost of \$210,779. There were over 51 positions advertised for 29 entities in 10 of the CDQ communities.


Below is Brian Venua's experience as a KDLG Reporter in Dillingham

2021 Seasonal Employment Participation by Community

Bering Sea Employment

BBEDC assists Bristol Bay watershed residents that are interested in employment with companies that operate in the Bering Sea. Residents are assisted with submitting applications to the companies of their choosing, pre-employment screenings, traveling to the job site, or obtaining gear and supplies that are necessary for new hires. Employment opportunities are available

with BBEDC partners on pollock boats, longliners, crab boats, multi-species bottom fish boats, floating processors, and in shore-based plants. Positions are available year-round. In the first quarter of 2021, three residents worked for Alaskan Leader Fisheries and earned wages that totaled \$81,525.

Internships In-Region Internship Program

The In-Region Internship is a more specialized temporary employment and training opportunity for residents that is offered through a partnership between BBEDC and regional employers with one of the goals being eventual full-time employment. Applicants will either demonstrate they have prior knowledge, interest, or work experience in a particular field, or they are needing to fulfill an educational requirement that necessitates a certain number of hours spent in a field related to their educational path. Employers work with residents to map out a learning plan that upon completion, shows an intern improved or learned new skills that would help them in the field of interest. There were three internships in 2021, an Accounting Technician III, Bookkeeper, and an Administrative Assistant at a total cost of \$27,307.

Youth Internship Program

The Youth Internship Program provides short-term employment to youth of the region, ages 14-17. For 4-16 weeks, interns are given the opportunity to work with local employers and gain important workforce skills. Whether it is working with their hands in outdoor laborer positions or working in an office and growing skills related to computers and phone etiquette, the interns are guided through a personal learning plan. This mutually beneficial program also gives employers of the region an extra set of hands when there is more work to be done, while training the future workforce of our region. Twelve youth from four communities participated in 2021, with a total program cost of \$48,169. Alex Buholm wrote about her experience finding an internship as the Assistant Harbor Master for the City of Dillingham.



"I would like to say a big thank you to BBEDC for helping me find a summer job with the City of Dillingham harbor office last summer. BBEDC staff and the Harbor Master helped me by opening doors and helping me find awesome opportunities for me to follow and help guide me to think about what I would like to do later in life. Training Vocational/Technical Training Program

In 2021, BBEDC assisted residents attending trainings or earning certifications in programs including Extended Esthetics Program, Plumbing and Heating, IT, Industrial Electric, Heavy Equipment Operator, CDL, Commercial Pilot, HVAC & Refrigeration, and more. The goal of the Vocational/Technical Training Program is to help those who are unemployed or under employed gain necessary certifications or attend trainings to increase employability. The program also works with residents needing trainings to maintain current certifications or that are mandated by their employer. Thirty-two applications were approved with 29 BBEDC CDQ residents receiving training at an expense of \$113,864.

Community/Group Training Program

Training requests are submitted to BBEDC by local village, city, borough governments, and known training facilities. Community/Group trainings are either directly related to the fisheries or could benefit the community or its residents by increasing their capacities and ability to fill local specialized positions. Through the Community/Group Training Program, forty-one residents from Aleknagik, Dillingham, Levelock, Manokotak, Naknek, Pilot Point, Togiak, and Twin Hills attended trainings,

most of which were hosted within their home communities. BBEDC contributed \$40,311 towards the trainings/events listed below. BBEDC also partnered with BBRCTE to host a career fair in March. The event was held through an interactive virtual platform that allowed thirty-nine different organizations from all over the US to engage with region residents and discuss upcoming training, education, and career opportunities. Ninety-three community members, classrooms and individual students from the Dillingham City School District, Southwest Region School District, Bristol Bay Borough School District, and the Lake and Peninsula School District participated.

Southwest Alaska Vocational Education Center (SAVEC)

BBEDC provides funding for the SAVEC training program to gather individuals from within the watershed and provide them with short-term trainings without having to leave the region. Although there were more in-person trainings planned in 2021, surges in COVID made it difficult to safely hold all of them. Trainings have continued to evolve and SAVEC partnered with the local university and other virtual educators to offer online trainings and certifications. Classes were also offered in smaller sizes over a series of days to serve a larger number of students and provide more space for social distancing purposes. Through innovation, SAVEC provided training to 47 individuals across 6 communities at a total cost of \$40,337.

Education Bristol Bay Regional CTE Program (BBRCTE)

High school students can take courses that offer opportunities to learn about different career paths while earning college credits or certifications through the BBRCTE program. These courses are delivered through a collaboration between the Bristol Bay Borough School District, Lake and Peninsula School District, Dillingham City School District, and Southwest Region School District and offered either throughout the school year as blended courses at a student's school or via in person intensive courses. Many in person courses were delayed until the spring of 2022 due to a surge in COVID cases late in 2021. During the spring 2022 BBRCTE hosted a significantly larger number of students thanks to the flexibility of the school districts, the increase in numbers of interested students, and the financial support of BBEDC and other supporting agencies. One hundred and seventy-three high school students from Aleknagik, Chignik, Chignik Lagoon, Clarks Point, Dillingham, Kokhanok, Levelock, Manokotak, Naknek, New Stuyahok, Newhalen, Nondalton, Perryville, Port Heiden, Tanalian, Togiak, and Twin Hills participated and earned a combined 38 high school credits and 113 college credits. BBEDC continues its support of this program currently by contributing \$150,000 annually.



United States Coast Guard Maritime Basic Training Course

General Education Development (GED) / AAE Program Support

The Bristol Bay Campus (BBC) supports region residents through the GED/AAE Program. Staff works with students from around the region to ensure they can receive the necessary assessments, certificates and tutoring in order to continue their education and reach their goals. BBEDC contributed \$40,000 in 2021 to assist with these efforts. In the beginning of 2021, there were 3 residents from Dillingham and Aleknagik successful in obtaining their GED. With further outreach, the BBC registered 29 more students for the program, these students came from Dillingham, Egegik, Ekwok, Manokotak, and Togiak.

Education Nursing Program Support

BBEDC provides financial support to the Bristol Bay Campus (BBC) in their collaboration with the University of Alaska Anchorage Nursing Program. This in-region program gives residents who are interested in a career in nursing the opportunity to work with an instructor to get hands on clinical experience at the Campus in Dillingham's Nursing Simulation Lab. Students may earn either a Pre-Nursing Certificate or Associate of Applied Science in Nursing through a combination of distance courses, in-person skill labs, and clinical experience. This instruction and training also prepares students for the NCLEX exam, that is required for all licensed nurses in the state of Alaska. The Nursing Program had two students starting their second semester in the Fall of 2021. These

students worked weekly in the nursing lab and participated in community outreach events like the flu vaccination event. BBEDC donated \$10,000 towards maintaining the program within the region.

Student Loan Forgiveness Program

The Student Loan Forgiveness Program assists residents that earn degrees, certificates, or licenses and return to the region to work. This program supports residents over a series of years as they contribute their new skills to the region's workforce. After one year of working, residents can apply for a percentage of their loans to be paid off over the course of five years. The percentage increases annually until either all of the student loans are forgiven or the program limit of \$20,000 is reached. In 2021, three residents reached the end of their five-year participation, with two getting their student loans forgiven completely. In total, nine residents were approved for \$27,030 in loan forgiveness assistance.

Scholarships Harvey Samuelsen Scholarship Trust (HSST)

The Harvey Samuelsen Scholarship supports degree seeking residents who are attending universities full-time. Students can apply twice a year either in August for a full-year scholarship, or in January for partial funding and courses held in the spring. Scholarships are paid directly to the universities for the student's tuition, fees, and books with any remaining funds available to assist students with other expenses related to their education. In 2021, sixty-five full or partial scholarships were funded at a total of \$734,600.

Academic Support Initiative

BBEDC supports students from the region attending universities full-time through the Academic Support Initiative. The goal of the program is to ensure the success of students attending college outside of the region, by focusing on the most vulnerable. Freshman and Sophomore are more likely to drop out than upperclassmen, so more regular check-ins and attention is given to those students in their first years in college. The top three universities with Harvey Samuelsen Scholarship recipients attending also have Campus Coordinators to assist in a variety of different ways. Campus Coordinators are upperclassmen that can pass knowledge on to newer students and advise them on the campus and area they are new to. They also help students who request tutoring information and funding, and host monthly activities so that students can meet up and discuss any concerns or experiences they have had recently. In 2021, BBEDC had four Campus Coordinators at the University of Alaska Anchorage, University of Alaska Fairbanks, and Fort Lewis College, with a total program cost of \$24,744.

College Development Fund Program



The College Development Fund (CDF) seeks to alleviate some of the financial burden for residents that would like to take classes part-time and remain within the region, by assisting with the costs of tuition, books and fees up to \$1,500 per semester. This scholarship is also available to high school students interested in dual credit courses or taking college classes before graduation. Seventy CDF applications were approved throughout 2021 with total awards of \$86,518 supporting 47 residents. 

Regional Fisheries 4E CDQ Halibut Fishery

Participation in the 4E CDQ halibut fishery held steady at 13 fishers, the same as in 2020. Unfortunately, COVID still remained a factor, and only one processor purchased fish in Togiak. This resulted in a continuation of the reduced fleet compared to pre-COVID years. The 2021 fleet managed to catch 28,380 pounds of BBEDC's 58,200 pounds available in Area 4E, equating to 49% of the available quota. Sixty percent of the halibut landed was offloaded in the ports of Dillingham, Naknek, and King Salmon, with the remaining 40% sold to the processor in Togiak.














Quality Improvement Products Program

Remarkable chilling efforts continued across the bay in 2021, resulting in a good year for the exvessel value paid to fishers for their catch. BBEDC is delighted to have helped ten resident fishers receive a variety of quality improvement products worth \$23,264 to enhance their fishing operations. The products included insulated fish totes, slush bags, flexible sheet foam insulation, and padded deck mats. Captains who opt to utilize products like these receive a premium price for their catch and help increase the value of Bristol Bay salmon.



Pre-Season Advance Program

Eighteen local fishers were assisted with pre-season expenses totaling \$82,500 for items including nets, insurance, groceries, fuel, permit renewals and more. Resident fishers who hold a CFEC Bristol Bay salmon permit and need assistance gearing up for the season can access the Pre-Season Advance Program to address their specific needs. Pre-Season advances must be secured with a purchase order from the permit holder's processing company and are due to be repaid by July 15th of the year they are issued.



Regional Fisheries RSW Purchase Program


Refrigerated Sea Water (RSW) systems allow fishers to chill their catch by cooling the water in their fish holds to an optimum low temperature. This keeps the quality of their fish high and helps ensure they receive chilling bonuses when delivering their product. They also allow for more down time to rest as chasing ice can take time and energy from captains and their crew. BBEDC provides financial assistance of up to \$22,000 to assist qualified Bristol Bay watershed resident fishers with the purchase of RSW systems. In 2021, BBEDC spent \$20,070 to provide one resident fisher with an RSW system.

RSW Support Program

Many fishing operations in Bristol Bay depend on having a properly maintained Refrigerated Sea Water (RSW) system to help them deliver high quality salmon and receive a premium price for their catch. BBEDC offers annual grants of up to \$1,000 to help resident commercial fishers perform start-ups, conduct any necessary maintenance, and winterize their RSW systems. Technician travel costs can also be covered through this program when fishers need to fly a technician to their community to service a unit. In 2021, twenty-seven resident fishers received grant awards totaling \$19,409.



Regional Fisheries Vessel Upgrade Grant Program

Improving fish quality and harvesting efficiency by assisting watershed resident fishers with repairs and improvements to their fishing vessels and set net equipment is the goal of this program. Drift operations can qualify for up to \$35,000 and set net operations can qualify for up to \$17,500 to be used for deck and fish hold upgrades, engines, outboards, repairs, electronics, and other improvements. In 2021, twenty watershed resident fishers received \$330,634 in grants to help modernize, repair, and maintain their vessels.

In-Season Emergency Provision

The In-Season Emergency Provision is a provision of the Vessel Upgrade Grant Program. Qualifying resident drift operations can access up to \$35,000, and qualifying resident set net operations can access up to \$17,500 if they experience a catastrophic engine/drive train specific breakdown mid-season. Applicants who have received the full Vessel Upgrade Grant are not eligible as these programs share the same pool of funding. In 2021, BBEDC spent \$30,419 helping three resident fishers overcome their breakdowns and get back on the water.



Regional Fisheries Fisheries Habitat Protection Grant

2021 brought hope to the region as an Alaska District Court Ruling allowed the EPA to reinstate the 2014 Bristol Bay Proposed Determination and reinitiate the Clean Water Act Section 404(c) process. BBEDC assisted in the effort to protect the habitat that sustains Bristol Bay's vibrant fisheries, specifically from large scale metallic mining, by granting \$295,000 to United Tribes of Bristol Bay (UTBB) and Commercial Fishermen for Bristol Bay (CFBB). BBEDC is proud to support the efforts of UTBB and CFBB, and recognizes that the fight to protect our ample fisheries habitat is not over until permanent protections for Bristol Bay are in place.




Regional Fisheries Bristol Bay Ice, LLC (BBIce)



The Bristol Maid and Bristol Lady, BBEDC's two ice barges, continued to support chilling efforts by distributing ice during the 2021 Bristol Bay salmon season. The Bristol Maid was stationed off of Clarks Point, and sold 476,695 lbs. of ice to fishers, an increase of 36% from 2020. Also, with the help of the BBRSDA and Trident Seafoods, the Maid offloaded surplus ice to the Alaska Rose to be sold at the

south line of the Nushagak district. The Alaska Rose sold 33,458 lbs. of ice, making the total amount of ice that originated from the Maid, 510,153 lbs. The Bristol Lady sold 414,500 lbs. of ice in the Naknek/Kvichak district, a 19% decrease from 2020 which may be attributed to more RSW units in the bay, or boats spending less time in the Naknek/Kvichak district. BBIce is proud to have assisted in the remarkable bay-wide push to increase the quality and ex-vessel value of salmon harvested, a main goal since its creation.



Bristol Bay Science & Research Institute (BBSRI)

BBSRI is a non-profit research entity and subsidiary of BBEDC that has been involved in local fisheries research and monitoring for two decades.

In 2021, BBSRI completed its 20th year of conducting fishery research, monitoring, and policy analyses associated with the Bristol Bay salmon fisheries. BBSRI has taken a leadership role to mitigate the impacts of the state's fiscal crisis on managing the Bay's fisheries by continuing in 2021 the Bristol Bay Fisheries Collaborative (BBFC). The Institute completed very successful seasons operating the Port Moller Test Fishery and the Nushagak District Test Fishery. It continued work with commercial, sport, and subsistence users examining options to revise the Nushagak King Salmon Management Plan in concert with the Alaska Board of Fisheries. BBSRI engaged and collaborated at a technical level with the Nushagak Electric and Telephone Cooperative to design studies to assess possible impacts of a potential hydroelectric project on the Nuyakuk River.

Port Moller Test Fishery

This was the 18th year that BBSRI operated the Port Moller Test Fishery (PMTF) to provide in-season information about the destination and abundance of the annual sockeye salmon run for fishery managers, fishers, and processors. The 2021 test fishery accurately characterized the timing and composition of the largest sockeye salmon return to Bristol Bay on record (67.7 million fish). BBSRI was able to provide real time information from the test fishery to thousands of people engaged in the fishery, including managers and industry. The fishery successfully captured 40.4 million sockeye salmon valued at \$250 million to fishers.

New in 2021, BBSRI led an effort to deploy and test the feasibility of a high-throughput laboratory on one of the test vessels. A first-of-its-kind in the world, the lab was constructed with funding from BBSRI, salmon fishermen, processors, and ADF&G. The feasibility study was a huge success, proving that we can obtain accurate and more timely stock composition estimates with a vessel-based lab than shipping samples to Anchorage for analysis.

Bristol Bay Science & Research Institute (BBSRI) Bristol Bay Fisheries Collaborative (BBFC)


Since 2017, BBSRI has worked with fishermen, the salmon processing industry, local boroughs, cities, and villages to provide ~\$3 million to support a world-class management program of the Bristol Bay salmon. BBSRI has matched contributions from organizations (and individuals) on a 1:1 basis over the last five years, and by doing so has provided \$1.5 million. The BBFC process has helped to clearly define a world-class management program for the Bay and sent a clear message to the State Legislature and Administration of the value of fisheries management in Bristol Bay. Recognizing that value and acknowledging BBSRI's efforts with BBFC, the State of Alaska Legislature passed a 2-year budget increment of \$1.6 million in 2021 to go toward BBFC-supported projects. BBFC is a great example of BBSRI's innovative leadership to tackle challenges facing the fishery and the Bristol Bay region. More details are available at the BBFC webpage: www.bbsri.org/bbfc

The Future

BBSRI will continue its efforts to financially support a world-class fishery management system through BBFC and is working with stakeholders to rebuild the State of Alaska's budget for managing the salmon fishery. BBSRI will also complete its work on the Nushagak king salmon management plan. Plans for 2022 include a fully operational at-sea genetics lab at Port Moller. The lab will improve the timeliness of information from the test fishery and substantially improve the costeffectiveness of the program. The at-sea genetics lab is another example of BBSRI's leadership and vision to build and maintain a world-class management system for the region's valuable salmon fishery.

CDQ/IFQ Harvesting Activity

BBEDC generates royalties by contracting with harvesting vessels and processors for a share of the revenue generated in the harvest and sale of CDQ and IFQ allocations. These royalties help support the programs and other work provided by BBEDC. Additionally, contractual arrangements with these harvesters and processors typically require the partner provide employment opportunities for local residents.


Each year BBEDC receives CDQ allocations of Bering Sea and Aleutian Island groundfish, crab, and halibut. These allocations typically fall into three harvesting categories: directed, bycatch, and some combination of both. Allocations of species that are primarily harvested through directed fisheries – pollock, for example – generate considerable revenue for BBEDC. Bycatch species, like Greenland turbot and arrowtooth flounder, do not necessarily support a directed fishery on their own but are valuable, retainable bycatch. These species allow the more valuable directed fishing operations to fully utilize their allocation and maximize royalties paid to BBEDC. Finally, some species, like Pacific cod, have a large component dedicated to directed fishing but require some portion to be used for bycatch in other targets. These fisheries are valuable both as a target fishery and as bycatch for other groundfish target fisheries.

BBEDC's Quota Manager works with harvesting partners to balance the CDQ allocations between partners based on a number of factors to maximize the benefits to BBEDC. In 2021 challenges due to COVID-19 remained. BBEDC and its harvesting partners worked together to address those challenges and continue working towards BBEDC's mission.




BBEDC Harvesting Partners for 2021





Transparency Report

Director Compensation Policy

BBEDC compensates its Directors who attend board and committee meetings with a meeting fee and travel/per diem. BBEDC Directors receive a flat \$500 per day meeting fee. BBEDC Directors are appointed by community resolution for up to a three year term and may be replaced in accordance with BBEDC By-Laws.

Related Party Transactions

BBEDC reports any transactions over the amount of \$20,000 with any director or their family members. In 2021, there were three related parties who participated in BBEDC's programs and received benefits in excess of the \$20,000 threshold. Mark Angasan, a BBEDC Board Member, qualified and received program benefits of \$34,269 in the Vessel Upgrade Program. Frank Gloko, nephew of Board Member Louie Alakayak, Sr., qualified and received program benefits of \$21,796 in the Vessel Upgrade Program. Peter Nanalook, grandson of Board Member Jimmy Coopchiak, qualified and received program benefits of \$51,941 in the Vessel Acquisition Program, of which \$22,000 was an RSW incentive.

Legal Proceedings Involving Directors

BBEDC reports any pending litigation between itself and any Directors. There is no such litigation for 2021.

Auditor Relationship

BBEDC has had no disagreements with their auditor, KPMG, LLP, during the past two years. In addition to audit services, KPMG, LLP also provides tax and tax consulting services to BBEDC.

Committees

The BBEDC Board of Directors has the authority to create and dissolve committees and appoint persons to serve on committees. The Finance & Budget Committee is responsible for the budget, financial statement review, and monitoring of the performance of the investment funds. The Finance & Budget Committee met on March 10, June 1, September 8, October 7, and November 3. Current members include: Robert Heyano, Chair; Hattie Albecker; Gerda Kosbruk; Victor Seybert, and Richard King. The Audit Committee is responsible for the oversight of the annual audit and other issues governing corporate governance, disclosure, and responsibility. The Audit Committee did not meet in 2021. Current members include: Robin Samuelsen, Chair, Betty Gardiner, and Fred Angasan, Sr.
