**Accredited Marine Surveyor member (AMS)** : Surveyors who have accumulated time in the profession and have proven the technical skills necessary for designation as AMS

**Surveyor Associate**: marine surveyors that do not yet meet prerequisites for acceptance as Accredited Marine Surveyors

**Third Party Fishing Vessel Examiner**: members designated to perform inspections under the SAMS USCG third party program in accordance with the commercial fishing industry vessel safety act of 1988

**Navtech United States Surveyors Association (USSA)**: proven independent leader in marine surveyor training, offers Master Marine Surveyor (MMS) certification

**The American Boat & Yacht Council (ABYC)**: non-profit, member organization that develops voluntary global safety standards for the design, construction, maintenance and repair of recreational boats

**Principal Marine Surveyor**: an expert on the ships hull, machinery, materials, equipment, and safety systems
